- Tax receipts can be issued for cash donations to the name appearing on cheques unless otherwise requested in writing.
- Gift certificates given directly by the issuer are eligible for a business receipt only.
- Gift in kind donations may be eligible for a tax receipt provided that the item is (a) tangible property (b) given voluntarily (c) a purchase receipt or other appropriate proof of value is attached.
 - Tax receipts are no issued to businesses; instead, a business acknowledgment will be provided.
 - Contributions of services, that is, of time, skills or efforts, are not property, and therefore they do not qualify as gifts for purposes of issuing official tax receipts. Therefore, donated items made by the donor are eligible for tax receipt for <u>cost of materials</u> only. Please attach purchase receipts for supplies.
 - For items acquired within the past three years, the CRA deems fair market value of the item is equal to the lesser of (a) the property's actual cost at time of purchase (donor signature and proof of purchase required) or (b) appraisal or equivalent deeming the current fair market value.
 - Item which are homemade, antique or works of art over the value of \$1000 require a professional appraisal before a tax receipt can be issued.
- Charitable tax receipting for gift in kind items are subject to verification of FMV and approval by the Brant Christian School Society Board of Directors.
